Dear Leader Schumer, Speaker Pelosi, Leader McConnell and Leader McCarthy:

Thirty million frontline essential workers have come to work every day during the COVID-19 crisis to provide the services and products needed for Americans to stay home and stay safe. This workforce was designated by the Centers for Disease Control and Prevention's Advisory Committee on Immunization Practices as priority Phase 1b vaccine recipients.

But as COVID-19 spreads, states create divergent policies and access to vaccines remains challenging, absenteeism increases and our ability to continue to keep essential goods and services readily available for all Americans is threatened.

We need innovative solutions to address this substantial problem, and we request that you include directive language and, if necessary, funding in the COVID-19 Relief Package encouraging the Federal Emergency Management Agency (FEMA) and the National Guard to work with states on mobile vaccine channels for our nation's frontline essential workers. Mobile vaccination programs are currently being piloted by states and local emergency management and public health officials that take the vaccines to the people where they gather, which reduces their exposure and relieves the burden of finding vaccination sites. These mobile vaccination centers complement – not replace - other vaccine access channels being implemented, including direct to retail pharmacy access.

### Proposed directive:

"FEMA, in collaboration with the National Guard, is directed to explore the status of state-based mobile COVID-19 vaccination pilot programs and assess their scalability to improve vaccine delivery to frontline essential workers."

A number of states and localities have unnecessarily exacerbated those risks with inconsistent approaches to vaccine distribution that at times have ignored CDC recommendations. We believe funding mobile vaccination centers will help to efficiently vaccinate the 30 million frontline essential workers designated by CDC as critical for
